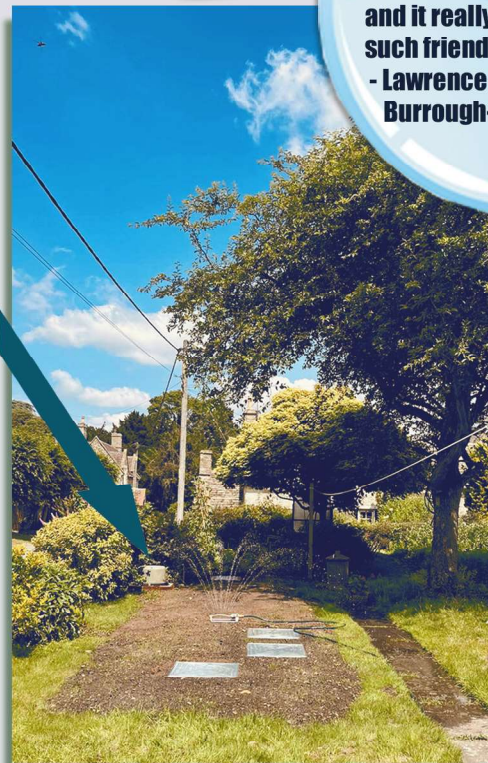

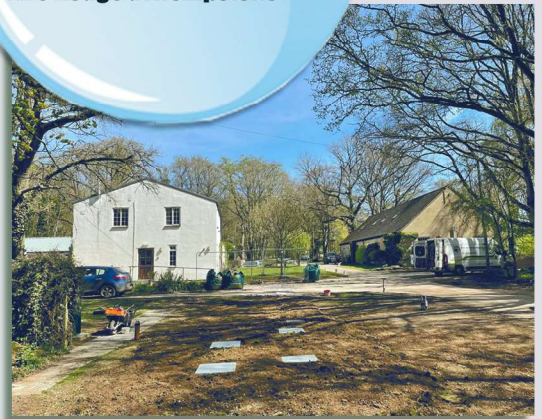

## Maintenance and Service

CM Environmental offer annual service contracts on our Sewage Treatment Plants and Pumping Stations by our British Water accredited engineers. This entails ensuring that your product is running efficiently and safely and is intended to prevent any issues arising. A full-service history on your plant can help with any possible insurance claims, and with any prospective sale on a property. In the case of treatment plants, it also means that you are adhering to the Environment Agency's Binding Rules if you are under the required flow to require a permit to discharge.



CM also specify, supply and install adoptable pump stations working with the relevant water authority for the area.

Having a service contract with CM also means favourable rates and priority for a call-out, should you ever require one. We will phone you each year to remind you, because we understand being underground, it is easily overlooked. Overall, our aim is to offer our organisation skills, knowledge, and expertise, to prevent the product from causing any disturbance for our customers.

Our engineer comes equipped in case there is anything he/she can improve with regards to the running of the product on site there and then. Depending on the product your tank will require an annual de-sludge, and this is something we can organise for you as part of the service. We can be flexible in terms of dates and times that suit you, and if you aren't available on the day, and there is access, our engineer can still attend. After attending, you will receive a full report including feedback and any findings, for your records.



Our engineer will come to site, and complete several checks on the system including: The electrics: Compressor/s, Pump/s, Alarm/s, Socket/s, Control Panel, The effluent quality in all chambers, including bacterial growth. Internal baffles, media, kiosk/s/housing, nuts, and lids
